As we continue to navigate through this new year in Lake Nebagamon, many things continue to have a different look and feel to them. As the snow flies and we face the challenges that come with weather and other more well known illnesses such as the flu, it is important we all continue to do our best to keep those around us safe and healthy. With that in mind, the Village Board has made the following determinations for Village owned facilities moving forward into the winter months.

**Ravine Campground:** It was determined by the Village Board at the July 7, 2020 Board meeting that Ravine Campground will remain closed for camping throughout the remainder of 2020. It is not possible for the Village to maintain the level of cleanliness that restrooms would be required to have during this time. This will be reevaluated in the spring of 2021.

**Auditorium Events:** It was determined by the Village Board at the February 9th Board meeting that the Village will resume scheduling new rental agreements. The capacity for these events will be 20 people downstairs and 75 upstairs, with only one event scheduled per weekend on one level of the building. This will continue to be reviewed as COVID numbers from the County are monitored.

**Village Office:** The Village office will continue to operate by appointment only. There is now a secured lockbox located on the front of the Auditorium, to the left of the front doors. This box can be utilized for dropping off sewer payments, land use permits, any correspondence that needs to reach the office, for the return of absentee ballots, or any other materials that need to reach Board members. It is checked daily. Village Administrator Amy K. The village office phone number is 715-374-3101 and has a messaging system that is also checked daily. The fall and winter months see us juggling school aged children with a schedule much different than the past with a heightened risk of children needing to quarantine if exposed by those around them. At short notice, it is possible that staff will need to work remotely from home to accommodate this situation. We ask for patience and thank you for your understanding as we balance all these different scenarios.

**Beach and Lower Level Auditorium Restrooms:** The basement level bathrooms at the Auditorium are now closed for the Winter season.

**Lake Nebagamon Ballfields:** The bathrooms and ballfields are closed. The facility will continue to be a landing for life flight through the winter months.

Personal businesses around the village will be maintaining hours according to what they feel is best to each of them, individually. Now, more than ever, it is imperative the community support our local businesses, small shops and restaurants. Contact them directly with questions, and keep an eye out for their announcements on social media as they change their policies to accommodate COVID outbreaks.

It is our hope that despite these unpredictable times, our community will continue to move forward carefully and patiently, while still finding ways to enjoy all the things Lake Nebagamon has to offer.
